Weed Control Program Update

The lake was treated June 6<sup>th</sup> with Diquat. The milfoil and curlyleaf pondweed are both going down. Diquat has a shorter restriction time than other herbicides. Lily pads are not as bad this year. Pondweeds in the canals and other shallow areas of the lake can be treated with Aquathol. Other parts of the lake can be harvested. Another survey will be done the week of June 20<sup>th</sup> and Pam will mark harvest areas.
