The balance of the rental fee is due no later than 30 days prior to reservation date.

RESERVATIONS – The Montcalm County Controller’s Office will begin taking reservations for **full weeks or more** on Monday, January 3, 2012 at 8:00 a.m. **Reservations will ONLY BE TAKEN via TELEPHONE. NO WALK-INS!**

Because we receive such a large volume of phone calls, we will again be accepting reservations via a first call, first pick, call-in system. To make reservations on January 3rd, **calls MUST be placed to 989-831-3599.** You will reach a voicemail box instructing you to leave your name and telephone number. **Calls will be returned in the order received starting – Monday, January 3, 8:00 a.m.** **Calls will not be returned until the afternoon of Wednesday, January 4th.** Reservations for anything **less than full weeks** will begin being taken February 1, 2012 at 8:00 a.m.

- * **Resident rates** are reserved for persons who live in Montcalm County **OR** are property owners who can provide proof of ownership (i.e. property tax number or copy of tax bill).
- ** **Non-Profit Organization rates** are reserved for “Montcalm County based” non-profit organizations providing proof (non-profit ID number).

CANCELLATIONS MUST be received, **in writing**, no less than **60 calendar days** prior to the first date of reservation to receive a full refund of your rental fees and \$100 deposit. Cancellations in **less than 60 days** will result in non-refund of the \$100 deposit and 50% of the rental fee.
