

DAY PARKS

MC CARTHY PARK

Located on M-91 north of Greenville between Turk Lake and Langston.

DESCRIPTION: Features an abundance of shade trees and woodland nature trails with frontage on the picturesque Flat River. It offers 3 covered pavilions. Amenities include a 56'x64', two 28'x32' pavilions, picnic tables and grills, playground equipment, nature trails, parking and restrooms.

The rental fee: The large (center) pavilion is \$100 for full use of it, or, \$50.00 for only half of it per day. The rental fee for the two smaller pavilions (North or South) is \$50.00 per day. The rental fee for an area of eight (8) picnic tables on the grounds (not in a pavilion) is \$40.00.

ARTMAN PARK

Located 1 ½ miles West of Howard City on the corner of M-82 and Amy School Road.

DESCRIPTION: Our foot bridge has become a popular spot for summer weddings. Amenities include picnicking, back woods hiking, large tracks of woodland and frontage on pristine Tamarack Creek including an island connected to the shore by a footbridge.

The rental fee: Groups of tables in outdoor areas may be reserved for special occasions. For an area of eight (8) picnic tables, the rental fee is \$40. The bridge area rents for \$40 per day.

KRAMPE PARK

Located south of Amble on Church Rd. between Masters Rd. and Amble Rd.

DESCRIPTION: This Park covers prime recreation land with large shade trees and frontage on Winfield Lake. Amenities include a boat launch, large pavilion, picnic tables and grills, playground equipment, parking, and restrooms.

The rental fee: Pavilion is \$100.00 for full use, or, \$50.00 for half of it. The rental fee for an area of eight (8) picnic tables, not under the pavilion, is \$40.00.

PLEASE NOTE

All Day Park cancellations must be made, in writing, thirty (30) days prior to the reservation date. There will be no refunds for cancellations which are made less than thirty (30) days before the reservation date.

SCHMEID PARK – This Park has no rental fee and is available first come, first serve.

Located on the north side of Townline Lake and the intersection of Robin Dr. and Caroline Dr.

DESCRIPTION: This Park offers areas for varied recreation with large shade trees and frontage on peaceful and scenic Townline Lake. Recreational facilities and amenities include playground equipment, a basketball court, picnic tables and grills, parking and restrooms.

BASS LAKE Park & Public Access – This Park has no rental fee and is available first come, first serve.

Located south of M-46 (E. Howard City – Edmore Road) on East Vestaburg Road.

DESCRIPTION: This Park offers a great place for picnicking and there's a small boat launch area to enjoy great fishing. The lake covers approximately a 100 acre surface area. Bass Lake is located in the southwest corner of Richland Township.

FLAT RIVER NATURE PARK – This Park has no rental fee and is open from sunrise to sunset.

Located on South Johnson Road, ½ mile south of Sidney Road from Gowen.

DESCRIPTION: This nature park offers a quiet, pristine, and fenced nature area with two walking trails – one is eight tenths (.8) of a mile long and one is one mile & eight tenths (1.8) long. It has 4,200 feet of frontage on the beautiful Flat River, not far from McCarthy Park.
