On November 10, 2008, the Montcalm County Board of Commissioners accepted the following rate schedule for Ford Lincoln Park for the 2009 rental season:

NOTE: A deposit of \$100 dollars will still be required for all rentals, along with 25% of the above stated rental fee within 10 business days of making the reservation.

The balance of the rental fee is due no later than 30 days prior to reservation date.

RESERVATIONS – NEW FOR 2009 – The Montcalm County Controller’s Office will begin taking reservations for **full weeks or more** on Monday, January 5, 2009 at 8:00 a.m. **Reservations will ONLY BE TAKEN via TELEPHONE.**

NO WALK-INS!

Because we receive such a large volume of phone calls, we will be incorporating a new reservation system for this year. To make reservations on January 5, **calls MUST be placed to 989-831-3599.** You will reach a voicemail box instructing you to leave your name and telephone number. **Calls will be returned in the order received starting – Monday, January 5, 8:00 a.m.** Reservations for anything **less than full weeks** will begin being taken February 2, 2009 at 8:00 a.m.

* **Resident rates** are reserved for persons who live in Montcalm County **OR** are property owners who can provide proof of ownership (i.e. property tax number or copy of tax invoice).

** **Non-Profit Organization rates** are reserved for “Montcalm County based” non-profit organizations providing proof (non-profit ID number).

CANCELLATIONS MUST be received, **in writing**, no less than **60 calendar days prior** to the first date of reservation to receive a full refund of your rental fees and \$100 deposit. Cancellations in **less than 60 days** will result in non-refund of the \$100 deposit and 50% of the rental fee.
