Motion by Nan Hagerman, supported by Paula Plank to approve signing the following contract with the road commission. Share cost of graveling Senator Road North of Colby to the pavement's edge for estimated cost of \$3,365.00, Bituminous overlay on Myers from Lake South to Elm, West on Elm to Grove, South of Grove to Lakeview, West on Lakeview to Sweet, South on Sweet to Belding, West and South to South Shore Drive. (.66 mile long x 20' wide.) at an estimated cost of \$35,546.00. Aye's all. Motion carried.

Motion by Nan Hagerman, supported by John Hagerman to advertise for the Budget Hearing on June 11, 2008 at 6:30 p.m. prior to the regularly schedule meeting. Aye's all. Motion carried.
